Staff procured bids and issued a contract to Mona Electric for \$6775, based upon the amount that was below the manager's authorization ceiling. After several attempts to commence the repair that met delay because of weather conditions and PEPCO requirements, Mona needed to revise its bid to accommodate county inspection & space requirements:

- Additional grounding required (two [2] ground rods, one [1] ground bar and solid ground connector) - based on the meeting with the Prince George's County Electrical Inspector: +\$475
- Add for enclosed circuit breaker instead of disconnect: +\$325

Staff approached the second contractor to verify that the scope quoted was valid. The analysis follows:
