Carl Gregersen spoke of the financial difficulty that he and others on fixed income will endure because of the recent real estate tax assessments. He also voiced concern about the yearly increases in co-op fees and suggested eliminating some maintenance positions to hold costs down. He mentioned instances where he witnessed maintenance employees wasting time and resources. Mr. Gregersen was encouraged to contact the management office immediately when such behavior is observed.

7b. Proposed Rain Barrels, 14L Hillside

On October 21, 2011, the member at 14L Hillside submitted a permit request to install two black in color Rainsafe rain barrels at downspouts in the yard. GHI rules state that granite is the only color allowed. The Architectural Review Committee reviewed the request and voted in favor of allowing black color rain barrels in this particular case. It was the sense of the Committee that the color black is not an incompatible color. The Board discussed the issue of and the following motion was carried:

7c. <u>Proposed Gardenside Fence with Gate Across Common Sidewalk Outside Yard Boundary, 11G Ridge Road</u>

This item was deferred since the member at 11G Ridge Road could not be in attendance.

7d. Proposed Double-hung Window in Gardenside Addition, 2D Gardenway

On October 30, 2011, the member at 2D Gardenway submitted a permit request to install replacement 3-piece horizontal sliding window and a double-hung window in the gardenside addition at that address. GHI staff pointed out that the proposed double-hung window conflicted with GHI rules and the matter was heard by the Architectural Review Committee on November 9, 2011. ARC voted 6-0-0 that the double hung window in the gardenside addition at 2D Gardenway be granted as an exception because it is an existing condition and is not an original GHI structure. After a brief discussion with the member present, the following motion was made:

MOTION: THE BOARD OF DIRECTORS DOES ALLOW THE INSTALLATION OF A REPLACEMENT DOUBLE-HUNG WINDOW IN THE GARDENSIDE ADDITION AT 2D GARDENWAY.

7e. Proposed Revision to GHI Shed Rules

A subgroup of the Board of Directors has been formed to further review shed rules. The Board discussed the task group's proposed revision to <u>IX. Storage Shelters - Sheds</u> offered for consideration that resulted from the Board's discussion on November 17, 2011. It was noted that the proposal allows trash sheds next to the home (where most people have them anyway), vinyl sheds (reinforced if over 50 sq. ft.), and 10x20 sheds for most block homes (since they have no attics).

CONSENSUS: THAT THE SUBGROUP MEET TO FURTHER REFINE THE REVISED LANGUAGE FOR STORAGE SHELTERS – SHEDS BASED ON TONIGHT'S DISCUSSION AND BRING IT BACK TO THE BOARD.
