7f. Change-Order for Installation of New Kitchen Cabinets and Countertops at 20D Ridge Road

The Mutual Ownership Contract of the deceased former member of 20D Ridge Rd was terminated earlier this year. After the unit is repaired and re-sold, GHI will recover the debts owed to the co-op and the remaining funds will be remitted to the member's estate.

On June 11th, the Board of Directors authorized the Manager contract with Rainbow International Restoration to repair 20D Ridge Rd for a total not to exceed \$16,335.00. However, the original repair specifications did not specify replacement of the kitchen cabinets and countertops; hence the bid prices obtained from the two contractors who responded did not cover those items. The existing kitchen cabinets and countertops are in a poor condition. Staff recommends that they should be replaced to ensure that the unit is resold quickly and the personal representative for the estate agrees.

Rainbow International has submitted a quotation for \$3,500 to procure and install new kitchen cabinets and countertops. Hence, with this change-order, the new repair cost would be \$18,350. Since the Board previously specified that the repair costs should not exceed \$16,335.00, staff is seeking authorization from the Board to spend an extra \$2,015 to allow installation of new kitchen cabinets and countertops in the unit.

<u>Motion:</u> The Board of Directors authorizes the Manager to sign a change-order in the amount of \$3,500 with Rainbow International Restoration to install new kitchen cabinets and countertops at 20D Ridge Road, for a total contract cost for repairs to the unit not to exceed \$18,350.00.

9. President

Skolnik said he would like to have a Board and Finance Committee work session scheduled for

Thursday, August 13th at 7 p.m. to discuss open HIP questions. He reminded everyone of the Strategic Planning Session scheduled on Sunday, July 19 beginning at 9 a.m. Skolnik encouraged all to attend and welcomed Board members to add new or existing discussion topics of importance. He also said staff is continuing the work on sealing up steam tunnels where possible; that the work is nearing 80% completion. Additionally, Skolnik announced that on Wednesday, July 15, at 7:30 p.m., a solar energy contractor will give a presentation on solar domestic water heaters in the Board Room.

10. Board Members

11. <u>Manager</u>

GM Ralph summarized Pepco's project that began two years ago to prevent outage failure whereby they installed new poles and lines. Pepco will soon embark on the second stage of the project involving vegetation management. Ralph provided the following highlights:

- 129 trees are targeted for removal in GHI; some might be on city rights-of-way.
- City of Greenbelt plans a public meeting on July 22 at 8 p.m. that will be advertised.
- Pepco has provided maps showing trees to be removed but not those to be pruned.
- GHI's Director of Maintenance, George Bachman will be the point of contact for members and Pepco's contractor.
- Project to begin within three weeks after Pepco is given permission by the city; Pepco must also gain GHI's permission as owner of the property and that individual members cannot give permission to Pepco to remove trees in their allotted yard space.

Ralph also said he met with Kimberly Knox of Green ACES about grants available for water quality projects from the PG County Storm Water Stewardship Grant Program due July 30 and a technical capacity grant on storm water management that is due September 17. GHI identified three sites that could benefit: 1) between 33 Ridge Road and 56 Crescent Road (storm water runoff at the underpass); 2) Woodlands behind 62 Court Ridge Road; and 3) 20 court of Ridge Road. An interested storm water environmental company is reviewing the sites to prepare proposals and Knox will assist staff in preparing the grant application.

Audit Committee member Irwin announced Ben Fischler's resignation from the Committee. Irwin stated that member Paul Kapfer has been appointed to fill the vacancy. Irwin was provided clarification to her inquiry about the consent agenda and procedures regarding fence removal.
